

## Certisecure Notice 15

Date: 7<sup>th</sup> February 2025

**Subject: Certisecure Enhanced Security Doors - Updated Standard PAS 24:2022 +A1:2024**

**Applicable to Scheme: STS201 - Certisecure Enhanced Security Doorsets to PAS 24**

Dear Certisecure Members,

There has recently been an update to the standard PAS 24, which the Certisecure STS201 Enhanced Security Door certification scheme is in accordance with.

### **The new issued standard is PAS 24:2022 +A1:2024**

The standard has been updated with an additional attack method, which will only be of relevance for products where the cylinder does not rely upon additional hardware to meet the requirements of PAS 24 Annex A.

If the requirements of PAS 24 are met by a combination of security items (e.g. additional security handle/escutcheon), it is not foreseen that any changes would be necessary to maintain your existing certified doorset specification.

There is clarification that the doorset manufacturer must take full responsibility for all components being supplied to site for the certified doorset. This is not a change to your existing Certisecure certification.

The instructions for assembly, installation, glazing, operation & maintenance must be provided with the doors. It is recommended that these instructions should indicate that installation is to be undertaken by a person suitably trained and qualified by knowledge and practical experience and provided with the necessary instructions to enable the required task(s) to be carried out correctly.

To allow for manufacturers of cylinder components to meet the new requirements of the test method within PAS 24:2022 +A1:2024, there is a co-existence period for certification such that PAS 24:2022 will also remain in force for Certisecure certification until the end of January 2027.

2025 Audit testing for Certisecure certified doorsets at our Element laboratory will be carried out in accordance with the standard that is stated on your scope of certification for the specific doorset being tested.

It is important that your Enhanced Security Doorset certification is updated to the latest version of the standard (PAS 24:2022 +A1:2024) by January 2027. To achieve this, you will need to be fully compliant with the latest standard by either providing evidence of cylinder compliance to PAS 24:2022+A1:2024 Annex A, or one of the alternative routes to compliance stated in clause 4.1.2. Evidence of cylinder compliance must be supplied to Warringtonfire prior to audit testing to the latest standard. Please discuss this with your component suppliers for evidence of compliance to latest standards.

If your Certisecure certified doorset is multi-classified (e.g. Security/Fire/Smoke Control), it is important to consider any further restrictions that are specified in the appropriate fire/smoke assessment report/s.

When this is complete, your Certisecure certificate will also be updated to reflect compliance with the new standard. When this is complete, you will be required to use the latest Certisecure labels on your products that state '**PAS 24:2022+A1**'.
