A log is maintained of all improvement activities taken to reduce the impact Doorpac Ltd has on the environment.

Environmental Improvement Activity Log

Listed below are actions taken by Doorpac Ltd to reduce the impact its business activities have on the environment.

- Purchasing recycled or waste materials from other manufacturers to use as packaging for our deliveries such as pallets and wooden bearers. We also reuse packaging provided with our supplied materials i.e. cover doors, card, bubble wrap.
- Surplus/non standard card is purchased from suppliers for use in our packaging process, reducing the impact of their wastage on the environment.
- The method of packaging has been refined to ensure that the product is at minimum risk of damage during transit and storage on site. This helps to prevent the environmental costs associated with producing replacement items for damaged goods.
- Delivery of completed goods is undertaken in the most economical method through the selection of the most appropriate vehicle type and by maximising the numbers of doors per pallet/delivery. Thus minimising the cost to the client as well as trying to reduce the overall vehicle millage.
- Controlled and efficient work methods ensure that there is the minimum amount of wastage in terms of materials and energy used in production. However where product is rejected the items are reworked wherever possible rather than scrapped.
- Waste paper, card and plastic which cannot be reused is recycled using commercial recycling facilities.
- Correspondence is undertaken by email or telephone where possible to reduce the requirement for printed materials.
- Recycled stationery (e.g. envelopes) is used where written correspondence is required.
- Supplying timber products we also have a responsibility to ensure that none of our products contain timber obtained from illegal sources. Where possible we ensure there is either PEFC or FSC chain of custody to provide documentary evidence that the timber source is both legal and sustainable.
- Doorpac Ltd is committed to the values of FSC & PEFC as defined in the Policy for the Association of Organisations with FSC-POL-01-004 V2 and PEFC ST 2002:2020.

As such Doorpac Ltd is neither directly nor indirectly involved in the following activities:

- a) Illegal logging or trade in ilegal wood or forest products;
- b) Violation of traditional and human rights in forestry operations
- c) Destruction of high conservation values in forestry operations
- d) Significant conversion of forests to plantations or non-forestry operations
- e) Introduction of genetically modified organisms in forestry operations
- f) Violation of any of the ILO Core Conventions as defined in the ILO Declaration on Fundamental Principles and Rights at Work 1998
